Powers of attorney can be distinguished by the type of faculties or powers granted, such as: General Power: This type of power is used to perform one or more acts that require broad faculties, i.e., not specific, and therefore indicates in the document that the attorney has the most general faculties to perform a certain act, for example, to attend a meeting with a fiscal authority, which may require showing, receiving, or signing documents, answering questions, or revealing information about the grantor. It would be unnecessary to describe each possible activity, so this type of document includes, for instance, general powers for lawsuits and collections, covering all necessary fiscal procedures. Special Power: This type of power is granted to attorneys to perform only a specific task or process, and therefore the power of attorney will include said task or process in the document, for example, faculties to make a payment in favor of liquidation to a worker who has left an organization. Any type of faculty or power (special or general) required for a transaction or process that the grantor must perform. In the case of special powers, it is necessary to indicate the specific activities that the agent will carry out. The difference between a letter of attorney and a power of attorney before a notary is that the former is prepared privately for the realization of a specific activity and does not constitute a public writing. On the other hand, a power of attorney before a notary is directly prepared and granted, i.e., signed, in the presence of a notary who will make the power official in a public document. There are legal acts that require powers established by a public writing granted before a notary. For example, the purchase-sale of real estate requires that the representative has a power granted before a notary, or representing someone else in court or signing credit titles such as checks or promissory notes, which also requires a power granted before a notary. 

Yes, whenever a person represents another, they must present a letter of attorney; without the letter of attorney, they cannot represent the grantor for performing certain transactions or fulfilling obligations before an institution or dependency. Who can subscribe a letter of attorney? Any person over 18 years old, who is not limited in their faculties (as determined by a judge), can sign a letter of attorney. The agent must also be over 18 years old. If one of the parties is a minor, they must sign it along with their father, mother or tutor. What is the duration of a letter of attorney? A letter of attorney can be issued for a specific period of time or indefinitely; in the latter case, it can indicate that once the act for which the power was given is completed, it will no longer have any effect or use. What should be done after completing a letter of attorney? Once the model is complete, it must be printed on at least one copy and signed by both the grantor and the agent, as well as witnesses, if necessary. It is not necessary to prepare games for each party; whoever requires a document that proves the power is only the agent. After signing the letter of attorney, the agent can present it before the authority or dependency where they will perform the transaction or process and keep it. What documents should be attached to a letter of attorney? Copies of the identification documents of the grantor, the agent, and in their case, the two witnesses must be added to the letter of attorney. Is it necessary to certify a letter of attorney before a notary for it to be valid? No, generally it is not necessary. Certifying a letter of attorney before a notary means that the person signing the document confirms in the presence of a notary that the signature included in said document belongs to them. Firming a document in front of a notary public simply means that the person signing it confirms their identity and signs their name before the notary, who then verifies that the signature is genuine. However, when issuing a power of attorney, the notary goes beyond just verifying the signature. They also confirm that the power will be given to someone for specific actions. A private written document signed by the principal can also serve as a power of attorney, without the need for a notary's intervention, as long as the scope of the apoderado's activities does not exceed 1,000 times the minimum general salary in effect at the time of signing. Do witnesses need to be present when signing a power of attorney? Yes, if the matter is worth more than 50 times the minimum salary. If it's less or the specific task doesn't require them, they're not necessary.

A power of attorney must include: the principal's name, the apoderado's name, the activities to be performed by the apoderado, the apoderado's express acceptance of their powers, and the date and place of signing. What laws apply to a power of attorney? The "Mandato" section of the Federal Civil Code and its corresponding provisions in the civil codes of each federal entity in Mexico.
