Upon completion, a certificate is issued which learners should print or save for their records, as the Center for Development of Security Excellence (CDSE) does not keep such records. The content is optimized for viewing on Edge or Chrome browsers. For those using Internet Explorer, adding "to trusted sites via Internet Options is recommended. The course, updated on February 27, 2024, spans two pages and includes questions and answers. It is part of the DoD Annual Security curriculum and covers the latest updates, including a new Controlled Unclassified Information (CUI) module, an enhanced operational security (OPSEC) module, and a revised personnel security module in line with Trusted Workforce 2.0 standards. Participants will find a pre-test and a post-test within the course, which must be completed in one sitting to earn a certificate. A passing score of 75% on either test is required for certification. It's important to note that the course will not record your progress, so it must be finished in one go.
