Those unable to manage their household on their own may be eligible for assistance. This may involve a doctor's certificate or a report from a medical services organization. The document should clearly demonstrate why you are unable to perform household tasks and how the support is essential for your recovery or stabilization. If you meet these requirements, you can submit an application for household assistance at your TK health insurance provider. You will need various documents, which must be submitted together with the application. Application form: Download the application form from the TK website or request it by phone. Complete the form fully and truthfully. Doctor's certificate: Obtain a doctor's certificate confirming that you require household support due to your illness or health limitations. The report should be as detailed as possible and clearly demonstrate the medical necessity of household assistance. Report from a medical services organization: In some cases, a report from a medical services organization may be required. This might apply if long-term or particularly complex measures are needed. Your doctor can inform you about the need for such a report. Income proof: Typically, you will also need to provide proof of your income, such as pay stubs. The TK will review your financial situation to determine whether you must contribute financially to the household assistance. Certificate confirming lack of alternative support options: A doctor or other medical services organization can issue a certificate confirming that there are no other close individuals or family members capable of performing your household tasks. This document should be as specific and detailed as possible. After gathering all required documents, submit the application together with supporting evidence to the TK. Be sure to adhere to the specified deadlines for submitting the application. Nachdem Sie Ihre Antragsunterlagen bei der TK eingereicht haben, wird Ihre Anfrage geprüft und die Haushaltshilfe kann gewährt werden. Es ist möglich, dass weitere Informationen benötigt werden, um sicherzustellen, dass die medizinische Notwendigkeit der Haushaltshilfe gegeben ist. Wenn Ihr Antrag bewilligt wird, erhalten Sie eine schriftliche Mitteilung von der TK, in der auch festgelegt wird, für welchen Zeitraum und Umfang die Haushaltshilfe bereitgestellt werden soll. Die TK übernimmt normalerweise die Kosten für die Haushaltshilfe direkt. Wenn Ihr Antrag abgelehnt wird, erhalten Sie ebenfalls eine schriftliche Mitteilung von der TK, in der der Grund für die Ablehnung erläutert wird. Es besteht die Möglichkeit, innerhalb einer bestimmten Frist Widerspruch einzulegen. Dazu sollten Sie sich anwaltlich beraten lassen, um Ihre Erfolgsaussichten zu prüfen. Der Medizinische Dienst der Krankenversicherung (MDK) kann auch eingeschaltet werden, um die medizinische Notwendigkeit der Haushaltshilfe zu prüfen. Der MDK erstattet der TK ein Gutachten, das als Grundlage für die Entscheidung dienen kann. Es ist wichtig, dass Sie bei einem persönlichen Gespräch mit dem MDK offen und ehrlich über Ihre gesundheitliche Situation sprechen und gegebenenfalls weitere Unterlagen oder Nachweise vorlegen.
