The 4Ever 4-in-1 Car Seat offers comfort and safety for your growing child with its adjustable features like recline, headrest, and harness system. Installation is crucial; failure to do so may result in serious injury or death. Read the instructions carefully before using this car seat. To secure the cup holders, match them to the right side of the seat, align the tabs with the slots, and slide down until you hear a "Click" sound. When choosing the seating location, consider your vehicle owner's manual recommendations and ensure a secure installation. Some vehicles may have specific requirements for where the car seat can be installed. The car seat can be installed using either the vehicle seat belt or the LATCH system; do not use both simultaneously. The LATCH system allows for a better fit and is required in all 2003 and newer model year vehicles, although some manufacturers began including it earlier. The manual advises readers to review their owner's manual before installing the car seat. If this infant car seat seems straightforward, still read these instructions carefully to ensure you're using it correctly. Keep reading on page 1818. Important note: Babies born prematurely or with low birth weight might be more vulnerable while traveling. The American Academy of Pediatrics advises that if not properly reclined, these infants could experience breathing problems when in a car seat. Consult your doctor or hospital staff before leaving the hospital to determine the best car seat for your baby. Here are some general guidelines: For rear-facing with a 5-point harness, babies under 1 year old must be facing backwards (4-22 lbs), while those between 22-40 lbs should also face backwards but can be forward-facing if able to sit up unassisted. Between 22-40 lbs, children can start sitting upright on their own and may be forward-facing. From 30-65 lbs, kids can use a booster seat with the vehicle's lap/shoulder belt. Once over 65 lbs, they must use a booster seat. If there's an issue, contact Graco Children's Products Inc. or the U.S. Government's Vehicle Safety Hotline for assistance. Remember, this child restraint needs to be disposed of 10 years after its manufacturing date, find the sticker on the back for details. restraint is only certified for use in aircraft when used with the internal harness system. This child restraint cannot be used in aircraft as a booster seat since they do not have shoulder belts. Contact the airline for their specific policies regarding car seats. Vehicle seat belt system MUST hold car seat securely. Not all vehicle seat belts can be used with a car seat.! If vehicle seat belt does not hold car seat securely, read "Vehicle Seat Belts" section 9-D and your vehicle owner's manual. ! Always secure car seat with LATCH or a vehicle seat belt, even when unoccupied. In a crash, an unsecured car seat can injure passengers.! If car seat is in a crash, it must be replaced. Review section 1-D for additional information about car seat usage. Please register your Graco car seat, within 90 days of purchase by filling out the prepaid registration postcard attached to the harness and mailing it in or registering online at [www.gracobaby.com/carseatregistration](http://www.gracobaby.com/carseatregistration). Child restraints can be recalled for safety reasons, so it is essential to register them with Graco Children's Products, Inc. at P.O. Box 169, Elverson, PA 19520-9901 or by calling 1-800-345-4109. You can also register online. To ensure your child's safety, always use the car seat correctly: • Rear-facing for infants under 22 lb (10 kg) • Forward-facing with a built-in harness system until maximum weight or height is reached • A belt-positioning booster seat is needed once the vehicle seat belt fits properly Check local and state laws, as well as AAP and NHTSA recommendations, for car seat usage. \*Graco recommends using its car seat with a vehicle seat belt.\*According to the American Academy of Pediatrics and National Highway Traffic Safety Administration's guidelines, visit [www.gracobaby.com/en-US/safety](http://www.gracobaby.com/en-US/safety) for more information on safe car seat usage.\*Vehicle seat belts should hold the car seat securely in case of an accident. Always secure the car seat using the lower anchor attachment or a vehicle seat belt, even when it is unoccupied. This helps prevent injuries to passengers.\*Never use a damaged or missing parts car seat again, as this could lead to serious injury or death.\*Do not use accessories other than those provided by Graco, except for a thin towel or mat to protect the vehicle seat, unless specifically recommended.\*Always check the LATCH system before removing it from the car seat. If using the lower anchor attachment, the connectors must be stored properly when switching to a vehicle seat belt.\*Never leave a child unattended, even while sleeping, as they may become tangled in harness straps and suffocate or strangle.\*Rear-facing car seats should be leveled correctly: too reclined can cause injury, and too upright can lead to breathing difficulties. The seatbelt must also be properly secured for optimal performance.\*Always follow the manufacturer's guidelines when using both lower anchor connectors and vehicle seat belts, as overusing these attachments may void the warranty or create safety risks.\*The Seat Belt Trainer is only compatible with certain Graco car seats, so make sure to check compatibility before purchasing. Additionally, never use this car seat beyond its recommended lifespan of 10 years after the date of manufacture.\*Graco advises against sharing or lending car seats unless you have full knowledge of their history. They also advise against buying used car seats.\*Always inspect the car seat for damage and hot parts, especially in warm weather, to avoid burns.\*Follow the manufacturer's guidelines for weight limits and height requirements for different positions: rear-facing with a 5-point harness, booster mode with a vehicle lap/shoulder belt, and highback or backless booster modes. In booster or seatbelt trainer mode, children over 65 pounds (30 kg) must be accommodated. It's essential to review state laws and AAP/NHTSA recommendations for guidance. Refer to page 10 for more information. For the seatbelt trainer mode with a vehicle lap/shoulder seatbelt, the child should be between 43-60 inches (110.1-152 cm) tall and at least five years old, weighing 50-65 pounds (22.5-30 kg). This child restraint system meets or exceeds all applicable Federal motor vehicle safety standard 213 requirements for use in motor vehicles. Additionally, it's certified for use in aircraft when utilizing the harness system without the lockoff. Ensure proper installation in forward-facing aircraft seats and follow instructions for routing the aircraft lap belt over the lockoff. Important notes include that this car seat is not certified for use in aircraft when using the lockoff or as a booster seat, nor in seatbelt trainer mode, since aircrafts lack shoulder belts. The car seat features various components, including the headrest/harness height adjustment lever, infant head and back support, booster shoulder belt guide, harness covers, chest clip, harness straps, buckle tongues, buckle, lumbar support, buckle strap, and cup holder. For rear-facing installation, refer to section 3-C, and for forward-facing installation, see section 4-C, but do not use the tether. Consult sections 10-E "Vehicle Seat Belts" and 10-F "Aircraft Installation" for more information. Contact your airline for their specific policies. In rear-facing mode, accommodate children weighing 4-40 pounds (1.8-18 kg) with a head at least 1 inch (2.5 cm) below the headrest adjustment handle. Infants under 22 pounds (10 kg) must be rear-facing. Ensure proper installation in your vehicle back seat, routing the lower anchor strap or vehicle seat belt through the rear-facing belt path marked with a blue label. 1. For infant seats, ensure child is seated with level indicator checked and only use Rear-Facing position if under 20 lb (9 kg). Children should ride rear-facing as long as possible until maximum height/weight limits are met then move forward-facing using built-in harness system. 2. Ensure vehicle seat location does not have active front air bag when using Rear-Facing mode. 3. To remove Seat Belt Trainer, follow steps: a. Attach tether strap to car seat's back and attach lower anchor. b. Remove lower anchor connectors from storage position. c. Move lower anchor attachment to rear-facing belt path marked with blue label. d. Recline car seat and place rear-facing in vehicle seat with base as flat as possible. 4. To extend lower anchor strap, press grey button and pull on strap for easier installation. 5. Install car seat by ensuring vehicle is on level ground and level indicator bubble is completely within blue zone. 6. With Lower Anchor Attachment 3-B, expose belt lock-off by loosening harness straps, raising headrest to highest position, unbuckling buckle and chest clip, then move cupholders out and lift off seat pad to expose plastic shell.
