Additionally, think about insurance coverage, extra services like laundry or meals, and facilities like Council Tax. Define cleaning responsibilities and schedules, as well as smoking and pet policies. Establish boundaries for the property, parking options, and guest limits, including overnight visitors. Consider implementing an "overnight guests rule" to maintain a comfortable living environment. Formalize these agreements in writing to avoid misunderstandings later on.
